

Medical 4th Chain

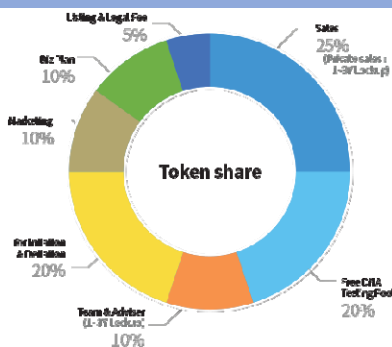
Summary

1. Seoul National University Medical Center-oriented project to utilize DNA data.
2. DNA testing is the basis of precision medicine that can turn disease into prevention, not treatment.
3. Among the data obtained through the DNA test, M4th focuses on female cancer and diabetes of Asian descent
4. Collect funds and collect and process genetic data through free DNA tests to sell data to pharmaceutical companies and medical institutions.
5. Pharmaceutical companies use the data to develop targeted women's cancer and diabetes treatments.
6. Make an immediate payment and conduct DNA test through M4th token to medical institutions in collaboration.
7. Income from the sale of DNA data is disclosed and distributed transparently to the DNA data provider on a blockchain basis.

Business model

- ◆ Created Money Pool (HP:Health Point, exchangeable by M4th as a common point within the platform) for free DNA testing with TGE funds
- ◆ Distribution of HP within the platform for DNA testing to the M4 constant condition holder
- ◆ When HP is distributed, DNA testing at the designated DNA labs and data donation
- ◆ Formulated DNA data and sold to global pharmaceutical companies, etc.
- ◆ Fill the sold amount back into the HP Pool and distribute the rest to the DNA data provider
- ◆ Providing free DNA testing HP even with M4th
